The problem we have is the 5 1/2 year old will start school this fall. I was going to help my son get her registered for school here in NC, but the school system wants proof of custody. “ My son was abused sexually at age 3 by my ex-husband as well as I. We moved out of North Carolina to Louisiana, to escape him as he started to stalk us after I received my legal separation which was in NC. I have sole custody. I then got my divorce in Louisiana, retained a courtier for my ex-husband was no longer to be found, after many attempts to be contacted. My son is now 15 and is in DSS custody due to false allegations, from his therapist since we have moved back to NC after Katrina in New Orleans where we lived since my son was 4 yrs. old. The Dss here in Asheville, NC refuse to give my son back to me and my partner, and since have contacted my absent ex-husband who hasn't seen or contacted myself or my family since my son was 4, has known where my family was, no child support has been paid, and abused both me and my son. I have recently found out that he knew where we were all this time. The Dept. is going to make my son see this abusive man. I talk to my son by phone at his temporary foster home, and see him on my visitation day, and he is becoming increasingly despondant everytime I see him. Does anyone know what can be done, or any attorney outside of Asheville that can help me as my sister is helping my abusive ex-husband and has been all this time. I had no idea this was going on. She knows many officials here, even the Judge presiding over my case here. This case gets more complicated everyday, I have a pro bono attorney, but this is the second one I've had as the first one made motion to withdrawl. My sisters husband tried to run me off the road the other day and I am now fearing for my life as my ex has my address because of being served papers for support since the Dept. found him. I called the Sheriff's dept. and no one has called me back, I told them it was my sisters husband that made this vehicular assault. Can ANYBODY give me advice or numbers of someone that can help me?? I am in dire need and major stress. I want my son back, and he wants to come back home, he is scared too, Some one, PLEASE HELP!! Thank you for any and all help.
