“ Jennifer-*The first thing you need to do is schedule a consultation with an attorney who knows family law and can help you evaluate your situation. It sounds like you need to get some good advice soon in order to protect yourself and your children. Once you and your children have lived in North Carolina for 6 months, North Carolina becomes the home state of your children, which means that the county where you live is the appropriate place to file a lawsuit for custody. You're probably going to be able to litigate the matter in North Carolina, not Ohio. While it's not clear from the facts you gave, North Carolina may have even have temporary emergency jurisdiction under N.C.G.S. 50A-204, which would enable a North Carolina court to enter a temporary custody order even if you haven't been here for 6 months. North Carolina also has jurisdiction over the divorce once you've lived here for 6 months. Any property or child support issues will probably still have to be dealt with in Ohio, but the divorce itself can be done here. It sounds like it's a good thing that you had the courage and ability to leave. Without a thorough discussion of the facts, I can't really give you an answer on how the abuse will effect the custody proceedings.
